

PARTICIPATION AGREEMENT

By submitting your film (Film) to Little Big Shots 2016 (Festival), which is run by Petite Grand Kaboom Ltd. T/A Little Big Shots International Film Festival for Kids (ABN 49 132 811 619) (LBS), you (Filmmaker) agree to the following:

1. All the information entered in the Little Big Shots online entry form is true and accurate.
2. You either own the rights to, or have permission to use, the footage, sound, music, images and all other contributions that are part of the Film to the extent necessary to submit the Film to the Festival and, if accepted, screen the Film at the Festival. Please note: if you have any doubts about any of the rights in the Film, you must notify the Festival at the time of submission.
3. Completing the online entry form, this Participation Agreement and paying the entry fee does not guarantee acceptance into the Festival.

If your film is selected to screen as part of Little Big Shots 2016:

1. You grant LBS a royalty-free, non-exclusive Australian/New Zealand licence to screen the Film as part of all Festival screenings between June 2016 and June 2017. A list of screening venues and events will be found on the Little Big Shots website (www.littlebigshots.com.au).
2. You agree to provide LBS with a screening version of the Film by no later than February 13, 2016.
3. LBS will prepare professional session compiles at its own cost for screening at all its venues. You grant LBS all necessary rights to copy and otherwise reproduce the Film for the purpose of making such compiles and otherwise screening the Film and promoting the Festival and LBS. LBS will retain a copy of the Film as part of its master compile for archival purposes.
4. You must notify LBS immediately if any of the rights in the Film become disputed or a claim is made against you in relation to the Film.
5. You must indemnify LBS and the Festival from all claims made against LBS or the Festival arising from or in connection with the submission of the Film, or any infringement of any intellectual property in connection with the screening of the Film as part of the Festival.
6. You grant LBS and the Festival a royalty-free, non-exclusive worldwide licence to use film excerpts, film stills, press kits and other promotional materials from the Film for publicity and promotional purposes in relation to the Festival, including on its website (www.littlebigshots.com.au), for a period of one year from the date of this agreement. LBS will not use your promotional materials for any third party endorsement or commercial activities without your prior written consent.

Signing this document indicates that you have read, understood, and agree to the above Participation Agreement as well as the Submission Information provided by LBS.

ENTRY FORM CHECKLIST

Did you include the following with your entry?

- Signed and completed 2016 participation agreement (one participation agreement per production). A scanned emailed version is acceptable.
- Have you paid the entry fee (either through Paypal or Direct Deposit)? Your film will not be considered a valid submission until all fees are paid.
- DVD of the entry clearly labelled with the film's title, or **online film submission**.
- Two high-quality and high-resolution images from the production (at least 300 dpi). These can be uploaded as part of the online entry form or emailed to info@littlebigshots.com.au as .jpps or .tifs. Image name should be same as film title (e.g. FilmTitle1.jpg, FilmTitle2.jpg).
- All films not in English must be subtitled or dubbed in English.
